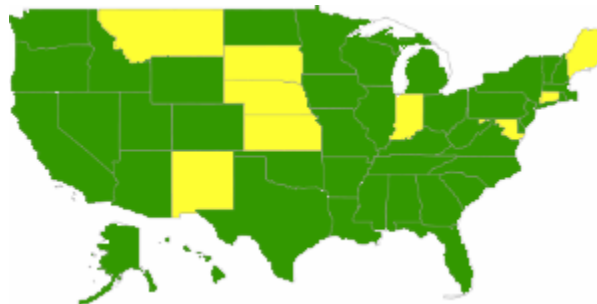

GENERAL NOTICE 2

DIRECTIONS FOR USE: - CONCENTRATE FORMULA - DO NOT USE UNDILUTED - Dilute 1.5 v/v% of PureCrop1 (2 oz. formula to 1 gallon clean water) - shake well - completely saturate leaves and stems For long term vibrant health of plants or crops continue spraying PureCrop1 once every 7-12 days at .75 v/v % (1 oz. formula to 1 gallon clean water). If necessary, adjust Ph to 5.8-7.0 before adding PureCrop1. - Thoroughly spraying/misting in early morning or evening hours is recommended. - Apply using conventional spray methods or through drip or broadcast irrigation. - Use PureCrop1 for treating and preventing issues causing crop damage such as Spider Mites, Broad Mites, Russet Mites, Aphids, Thrips, Whiteflies, Leaf Hoppers, Asian Citrus Psyllid, as well as Botrytis, Fusarium Wilt, Downy and Powdery Mildew.
